  - It was requested that future reports included arrest and prosecution figures.
  - A meeting to be set up between Speed Watch Groups and the Community Safety Partnership to find ways of making both groups feel better supported by the Police.
- It was requested that the recommendations be accepted.

## Debate:

- Further endorsement was received regarding the challenging work the Community Safety Team deliver
- Officers Denise Haylett, Paul Taylor and Terry Hughes were mentioned by name
- The CSU team were acknowledged for all there hard delivered to the town making residents, visitors and staff feel safe during evening socialising.
- Anti-social behaviour was raised as an area that had been reduced 43%.
