However, DM is working on a programme of clearing a "back log" of Major applications which are beyond the 13 week target date, with the clear objective of by 31 March 2018 having no major applications "on the books" beyond the 13 week target which do not have a resolution from Planning Committee to grant consent. The clearance of the backlog is impacting on performance (particularly in the short term), but should meant that 2018/19 starts with a "clean slate". Where a Local Planning Authority is satisfied that 1 part of a proposal is acceptable but not the other, then planning permission is refused. However, unlike LPAs, the Inspectorate are able to issue split decisions. In this case the Inspectorate agreed with the Council's decision entirely and therefore issued the split decision. Planning record this as 0.5/1 (as split decisions can be issued for other reasons) for consistency with previous years.
