The relevant representations within the meaning of S.35(5) of the Licensing Act satisfy the requirements of S.35 (6) of that Act and are as follows:

Please give the reason for the representation and detail the evidence supporting it:

The Premises Licence is for a large area of open land on the Colebrook Estate, North Farm, in Tunbridge Wells. It is used by the Premises Licence holder to host a variety of events, including festivals, weddings and other activities. These events can attract up to 4999 people, not including staff and contractors.

There is a body of water on the estate which is fenced off with a suitable physical barrier when Category 1 and Category 2 events are being held (from 1500 to 4999 patrons). This is to prevent patrons gaining access to the body of water on the event site and is maintained at all times the event site is open to the public. This is a condition on the current premises licence and is necessary for public safety.

The applicant has submitted an application to vary a number of conditions on the current licence.

PROPOSED VARIATION POINTS 1 TO 6

After reviewing the application **Kent Police have no objection** to the variations as outlined in the application identified in points 1 to 6.

It is understood by Kent Police, and confirmed by Mr Stephen THOMAS, that, apart from the proposed extension for the four events, the terminal hour for all other events will be as stipulated on the current Premises Licence.

PROPOSED VARIATION POINT 7

Kent Police raise objection to the request to vary condition 77 in the current premises licence identified in point 7:

"During a Large event a risk assessment to control access to the body of water on the event site"

The original condition, as identified as condition 77 on the current licence, was put in place for public safety. Large events cater for a crowd of between 1500 and 4999 which also includes overnight camping. To protect patrons from the dangers of the water, especially if they are under the influence of alcohol, it is necessary for the body of water to be separated from the patrons by a physical barrier and for this barrier to be maintained at all times while the site is open to the public.

Kent Police believe that the temporary installation of a physical barrier should not be based on a risk assessment as public safety could be undermined.

AMENDMENT TO CONDITION 14

Kent Police believes that in order to uphold the Licensing Objectives it is required that a responsible person be present at all times when Licensable Activities are taking place, whether the event is classified as a Large or a Small event. It is therefore requested that Condition 14 on the current licence be amended to read:

For all events the DPS or at least one Personal Licence Holder shall be present during the whole time alcohol is sold. For large events details of the nominated deputies shall be provided to the Licensing Authority and Police at least 30 days prior to the commencement of a large event.

NEW CONDITION

Due to the wide variety of "SMALL" events which could be held on the Colebrook Estate, covered by the Premises Licence, Kent Police request that a new condition be added to the existing licence which will enable responsible authorities to offer advice and guidance to the Premises Licence holder or their authorised representatives to ensure the licensing objectives are upheld.

"An event management plan for SMALL events shall be produced when requested by Kent Police or Tunbridge Wells Borough Council following consultation with the Premises Licence Holder, based on audience profile and police intelligence"

DUPLICATE CONDITION

Condition 21 is a duplication of condition 20
