Recommendations

Officer recommendation as supported by the Cabinet Member:

1. That £14,958.13 of developer contributions, received through a planning obligation 19/02136/FULL Dulwich Preparatory School Cranbrook, is allocated and released to Cranbrook and Sissinghurst Parish Council towards the replacement of Children's Play equipment in The Ball Field, Cranbrook.



1. Introduction and Background

- 1.1 This report seeks Cabinet Member approval to allocate £14,958.13 of Section 106 funding to Cranbrook and Sissinghurst Parish Council towards to the upgrading and provision of children's play equipment at Ball Field Play Area Jockey Lane Cranbrook.
- 1.2 The funding comes from a payment of £14,958.13 received through a planning obligation for Dulwich Preparatory School Cranbrook, planning reference 19/02136/FULL
- 1.3 Contributions have been held by Tunbridge Wells Borough Council pending Cranbrook and Sissinghurst Parish Council identifying a suitable project to allocate the funds
- 1.4 The agreement for Dulwich Preparatory School indicated that the funds should be used towards the upgrading and provision of children's play equipment at Ball Field Play Area Jockey Lane.
- 1.5 Cranbrook and Sissinghurst Parish Council engaged ROSPA to review the existing play equipment at the site with the result the multi play unit was condemned and unsafe to use
- 1.7 Cranbrook and Sissinghurst Parish Council proposal consists of the following equipment
 - Supply and install a Biba tube multiplayer unit supplied by Prelude Play.
 - Associated wetpour safety surfacing.
 - Groundworks to remove existing equipment.

Total cost £41,259.44

- 1.8 The Parish Council followed their procurement rules and obtained two quotes from reputable play equipment suppliers for replacement equipment accepting the lowest quote of £41,259.44
- 1.9 Cranbrook and Sissinghurst Parish Council are seeking the release of £14,958.13 of developer contributions relating to the development at Dulwich Preparatory School planning reference 19/02136/FULL as a contribution towards the total cost of the project with the remainder being funded by Cranbrook and Sissinghurst Parish Council.

2 Options Considered

- 2.1 Do nothing this is not an option as the agreement is specific towards the use of the funding and this proposal meets the requirement of the planning obligation.
- 2.2 Proceed, allocate and release the funding to Cranbrook and Sissinghurst Parish Council to contribute to the total cost of the replacement play equipment.

3 Preferred Option and Reason

3.1 The recommended and most durable option is to allocate the funds and contribute towards the purchase and installation of the play equipment. This will upgrade the play area and provide increased opportunities for interactive and social play. It does not create an ongoing revenue commitment for the Borough Council.

4 Consultation on Options

4.8 Cranbrook and Sissinghurst Parish Council has consulted with local users and carried out a tender exercise to select their preferred supplier.

5 Implementation

5.8 Cranbrook and Sissinghurst Parish Council will carry out all communication in connection with the work to be carried out via notices displayed in the play area and the parish newsletter.

Section 106 planning obligation agreements provide a mechanism for collecting contributions from developers through the planning process. Section 106 contributions may only be used for the purpose specified in the agreement. The report states that the proposed use for the contributions in this instance are in accordance with the terms of the agreement and the funding can be utilised as proposed.

Any necessary agreements or contracts entered into on release of the contributions must be in accordance with the Council's Contract Procedure Rules and should be in a form approved by the Head of Legal Partnership
