- 1.01 Private residential garden, with gardens to most sides, fronted by small road and footpath
- 2.01 To raise the canopy of both trees by 4 to 5 metres, trim and rebalance, if necessary.
- 2.02 The reason to contain the size of these mature trees which are shading neighbours' gardens, and which have been pruned in the past.
